Instead, ask the Lord to reveal men or women of God whose lives consistently reflect Christlike character, spiritual maturity, and faithfulness in serving the church.

Biblical Guidance for Deacons (Based on 1 Timothy 3:1–13)

As you pray and discern, consider whether the nominee demonstrates the following biblical qualities:

- Godly character – worthy of respect, sincere, self-controlled, and above reproach
- Integrity – not greedy for dishonest gain, trustworthy with responsibility
- Sound faith – holding firmly to the truths of the Christian faith with a clear conscience
- Proven faithfulness – tested over time and found faithful in service
- Healthy family life – faithful in relationships and manages household well
- Servant-hearted – serves willingly, humbly, and for God's glory, not position
